The past year also brought significant leadership changes to WILPF. Earlier this year, we celebrated the retirement of long-time WILPF Secretary-General Madeleine Rees, who was the driving force behind WILPF's growth for 14 incredible years. We also bid farewell to Laila Alodaat, who most recently served as WILPF's Deputy Secretary-General and devoted a decade of her career to the WILPE movement.

With Madeleine's departure came an opportunity for fresh leadership and we recruited Dr Amrita Kapur as the new Secretary-General of WILPF.



Transforming Mindsets

Throughout the year, we continued working to shift deeply entrenched mindsets and beliefs that perpetuate discriminatory and destructive forms of power.



Transforming Narratives, Promoting Justice: WILPF's Work on Disarmament and Arms Control

At WILPF, we believe that challenging and ending arms-related human rights violations requires transforming entrenched mindsets that link security to militarisation.

In 2024, we continued to challenge these narratives by advocating for policies that prioritise human rights, gender justice and disarmament in several disarmament and arms control spaces, including the Arms Trade Treaty, the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons, the Nuclear Non-Proliferation Treaty and more.

Through submissions to the Human Rights Committee, active engagement with the UN Human Rights Council (HRC), statements and an event in the Arms Trade Treaty's Conference of State Parties, we continued to denounce the destructive impacts of arms on human rights and highlight the gendered dimensions of such impacts.

Our efforts have been pivotal in influencing international understanding of the devastating human rights impacts of arms transfers and arms proliferation and in shaping states' and corporations' obligations under international human rights law.

For example, with regard to a UNHRC resolution on firearms, we <u>successfully</u> <u>advocated</u> for the need to recognise the gun industry's aggressive marketing practices and its exploitation of negative masculinities and gender stereotypes as one of the root causes of firearms proliferation.



Challenging Gender Apartheid

Throughout 2024, WILPF continued to be vocal in condemning gender apartheid in Afghanistan under Taliban rule through advocacy in various UN human rights mechanisms. Our statements, which demanded action from the international community, emphasised that gender-based violations and crimes, including gender persecution, are institutionalised, systematic and central to the Taliban's system of ruling, and enforced through harsh methods.

WILPF also actively contributed to efforts for gender apartheid to be recognised as a crime against humanity. A key highlight was the participation of Madeleine Rees, former WILPF Secretary-General, as a panelist at the event "Recognition of Gender Apartheid as an International Crime: Significance and Challenges", organised by the Geneva Academy of International Humanitarian Law and Human Rights in April 2024.





Reshaping Narratives on Men and Peace

To draw attention to the pervasiveness of militarised masculinities in our world and the role they play in perpetuating violence and insecurity, we launched a **powerful new podcast** in 2024 and hosted photography exhibitions in Amsterdam, Geneva, Utrecht and several cities across Colombia showcasing our photography collaboration, "Men and Love in Times of Conflict and Polarisation."

Together with PAX, the largest peace organisation in the Netherlands, we also launched a new <u>Community of Practice on Men, Gender Equality and Peacebuilding</u>.

Through this COP, 30 organisations and nearly 100 researchers, advocates and activists connect regularly to discuss men, masculinities, conflict prevention and peacebuilding topics.

In July 2024, members of the COP — including WILPF, Small Arms Survey, Pathfinders and GENSAC — co-hosted a convening on Militainment, the Arms Industry and the Marketing of #MilitarisedMasculinities, Weapons and War to understand and develop strategies to counter practices used by militaries and the gun industry to promote militarisation, war and the sale of weapons.





WILPF's Advocacy on Climate and Demilitarisation Heats Up

In 2024, we continued to gain traction as a leading voice demanding demilitarisation for climate justice.

Building on a long history of drawing attention to the devastating impacts of militarism on people and the planet, we published a new report on the entrenched power of the "nuclear priesthood" and fossil fuel industry, spoke out about the ecocide of Palestine and brought our demands for climate justice to COP29 in Baku, Azerbaijan.



Preventing Violence

We continued to champion a vision of peace and security defined by justice, equality and disarmament — not one where countries continue to arm themselves in the name of "security."







Challenging the Narrative on Palestine

In the background of the ongoing genocide in Gaza, we worked to keep the atrocities and human rights violations in the spotlight and persisted to demand a ceasefire and justice for the people of Palestine.

We advocated and sought to challenge the dominant narrative through a **series of blogs** and centred Palestinian voices through our **Voices from Gaza** podcast. We created **statements** together with other feminist organisations and rallied at multilateral spaces at every opportunity to make our demands for peace known. To highlight state and other forms of institutional repression at a global level and to support young people and activists, we begin documenting the mistreatment of students at pro-Palestinian protests around the world.

Our members protested, campaigned and sent letters to their official representatives to not only show solidarity but also demand an end to the unspeakable atrocities that the people of Palestine have endured for many years.

Young WILPF Engages in Digital Advocacy against Killer Robots

As warfare technology like autonomous killer robots rapidly advances, young people are increasingly expressing an interest in leading the movement to advocate against these dangerous and lethal developments. To help mobilise young activists around this issue, **Young WILPF published a blog post** with information about killer robots and how to raise their voices for change.

WILPF has continued to campaign for a Treaty banning autonomous weapons by actively engaging in conferences in **Sierra Leone**, **Vienna**, **Geneva** and **New York**. To support advocacy efforts several **reports**, **publication**, a **podcast** were produced.


LIMPAL Colombia Brings a Feminist Perspective on Remaining Obstacles to "Total Peace"

Since 2023, WILPF Columbia (LIMPAL) has leveraged Colombia's Universal Periodic Review (UPR) — a peer-review process through which each UN member state is assessed against its international human rights obligations — to advocate for the implementation of new government policies, including the "Total Peace" policy, through a feminist and antimilitarist lens.

This active engagement continued in 2024 with, among other actions, a **statement to the HRC** emphasising much-needed measures for the effective implementation of the Final Peace Agreement, especially its gender measures.

An interview with LIMPAL Colombia's Liliana García Larrotta, published by WILPF in 2024, provides a snapshot of LIMPAL's assessment of the **current status of women's and human rights** in the country. García also shed light on the obstacles that remain barriers to peace and justice in Columbia.





Sparking Dialogue and Advocacy during Women, Peace and Security Week

On 24 October, at the start of Women, Peace and Security (WPS) Week, the United Nations Security Council hosted an open debate on the WPS Agenda. WILPF representatives from Colombia, Palestine, Afghanistan and Syria attended the debate to demand the meaningful participation of women and civil society in peace and security — and challenge gendered power dynamics that are preventing true progress toward the implementation of the WPS Agenda.

During WPS week, we also held events on women's rights in Afghanistan, the role of gender in peace talks in Afghanistan and Syria and issued calls to the Security Council ahead of the 25th anniversary of UNSCR 1325.

Demanding Systems Change and a Multilateralism that Works at the Summit for the Future

In September 2024, the United Nations held the Summit for the Future — a high-level event that aimed to achieve consensus among world leaders on how the international system can meet existing obligations and new challenges. The Summit for the Future also saw the adoption of the Pact for the Future, an agreement that outlines actions to create a more peaceful and sustainable world.


In the months leading up to the Summit, WILPF contributed extensively to the consultation process, putting forward submissions and recommendations highlighting the urgent need for demilitarisation, disarmament and transformative change to our global system of governance. In May, WILPF's President Sylvie Ndongmo spoke at the UN Civil Society Conference in Nairobi, presenting recommendations from civil society on conflict prevention, disarmament and demilitarisation as key issues that should be centred in the Pact. WILPF members also mobilised to be present at the Summit of the Future itself and the two Action Days that preceded the Summit.





Advancing Our Understanding of Feminist Political Economy

Feminist Political Economy (FPE) is at the heart of WILPF's analysis of the root causes of violence and oppression. To help WILPF members across the globe gain a deeper understanding of FPE and how it can be leveraged in their work, we created a training module that empowers users to critically examine how capitalist structures shape gender inequalities and explore feminist alternatives for peace and justice. The module is available to WILPF members worldwide.

WILPF Spain Demands a Fossil Fuel-Free Future

At the end of 2024, WILPF Spain published a **new report** exploring the transition to a fossil fuel-free climate policy through various case studies from Europe, Africa and the Americas. The report also shares a look at the Section's work supporting the Fossil Fuel Non-Proliferation Treaty, which seeks to halt fossil fuel expansion, ensure a fair phase-out and enable a just transition for all.


Petrobromance: Mobilising Resistance to Violence and Exploitation

The fossil fuel and nuclear industries pose an existential threat to humanity and all species on our shared planet, yet they continue to be justified and supported by governments and industries driven by power and money.

Priesthood and Police Repression, we apply feminist and gender-transformative analysis to explore the operations and impacts of these industries, the way resistance against them is suppressed and how deeper collaboration across movements can bring progress toward a future of dignity, justice and peace.

Taking Messages of Peace Across Canada

From May to June 2024, members of WILPF Canada hit the road on a four-week, cross-country "On to Ottawa" Peace Caravan!

With a goal to build a country-wide movement for peace and justice, members and supporters took their advocacy messages from coast to coast. Together, they demanded that the Canadian government stop spending billions of dollars on the military and fossil fuel development, use taxpayers' money to address urgent social needs, act on the Truth and Reconciliation Commission's 94 Calls to Action, advocate for ceasefires and more. **Check out highlights from their incredible journey**.

"Beyond Survival": Challenging Traditional Approaches to Disaster Response and Recovery

In early 2024, we launched the campaign commemorating the first anniversary of the devastating earthquakes that struck Syria and Turkey. Anchored in a gendersensitive feminist analysis, the campaign drew on the invaluable firsthand insights of Syrian women impacted by the disaster. Utilising a diverse range of media — including videos, podcasts, analytical insights and actionable recommendations — we explored the intersectional nexus of conflict, gender and disasters, aiming to redefine crisis management and forge new paths in understanding, discovery and advocacy.

Presenting this project at key global forums, including the <u>Commission on the Status of</u> <u>Women (CSW)</u> and the <u>Global Platform for</u> <u>Women (GPW)</u>, we also stepped away from traditional advocacy to adopt more dynamic, human-centred approaches. We transformed panel discussions into film screenings and made sure decision makers and stakeholders saw the multilayered realities experienced by our partners and their communities.






Season Two of the *Think & Resist* Podcast



A POWERFUL MOVEMENT 21



A Constant Presence and Unrelenting Voice for Change

Throughout the year, WILPF had a strong and strategic presence at numerous key events held by the United Nations and civil society. Through our advocacy and active participation at events like the 68th session of the Commission on the Status of Women, COP29, First Committee, the 57th session of the Human Rights Council, the Summit of the Future, Geneva Peace Week, the 15th International AWID Forum and more, we strengthened our collective role in shaping global policies and networks aligned with peace, justice and equality for all.

Through our Activist Grant, we also supported members' participation in events such as the Common Space for Alternatives Meeting in Marseille, France, the Nordic Peace Conference, the Convention on Certain Conventional Weapons (CCW) Group of Governmental Experts on Lethal Autonomous Weapons Systems and more, ensuring WILPF members from around the world had a constant and meaningful presence in multilateral spaces throughout the year.

Peer Insights into Human Rights Advocacy

In September 2024, some of our Sections participated in an online peer-learning session to highlight their experiences in international human rights advocacy with the United Nations.

Open to WILPF members, the event offered insights into the motivations of Sections when it comes to engaging in international advocacy, including a desire to amplify local issues on a global stage and to monitor their governments' compliance with human rights obligations. Speakers shared that their Sections were focused on advocating for women's and girls' right to education, sexual and reproductive rights, child marriage, domestic violence, participation in public and political life and the implementation of the WPS Agenda.

In addition to enhancing Sections' understanding of international human rights instruments and processes, their advocacy efforts also increased their visibility and standing at both the national and international levels.

These advocacy efforts also contributed to tangible policy and legislative changes at the national level, including the adoption of a law and a decree regarding women's and girl's rights and a National Action Plan on UNSCR1325.


Bringing Activists Together for Change

In January 2024, we brought Syrian partners together under the Feminists for Change Movement project to fortify feminist knowledge and strategise. This three-day hybrid convening in Berlin presented a unique opportunity for Syrian feminists to connect, collectively reflect and reimagine Syrian feminist peace.



Campaigning for a Brighter Future

To mobilise the feminist peace movement around key issues, we ran highly visible social media campaigns and developed toolkits as resources to shed light on why peace is more important than before and how activists can use international campaigns to do their part from wherever they are. Some of our most noticeable campaigns were in the run up to **International Day of Peace** and Pride month.



A POWERFUL MOVEMENT 23





Empowering Members to Engage Men and Boys for Feminist Peace

Engaging men and boys is critical to the growth and success of the feminist peace movement, as we seek to transform deeply entrenched gender norms, shift mindsets and build momentum toward peace and justice in communities around the world.

With the support of sub-grants, WILPF Sections and partners in Afghanistan, Burkina Faso, Cameroon, Central African Republic, Colombia, Chad, Democratic Republic of Congo, Niger, Nigeria, Zimbabwe and Yemen implemented national and local level initiatives to engage men and boys for feminist peace.

WILPF Afghanistan in exile continued its work with male allies and hosted a strategic meeting bringing together religious scholars, youth activists and peacebuilders to analyse the challenges posed by militarisation and develop strategies for integrating feminist peace principles into Afghanistan's sociocultural framework.

WILPF Cameroon played a pivotal role in the institutional recognition of the term 'positive' masculinities: the second generation UNSCR 1325 NAP approved in 2024 included for the first time the concept of masculinities. Through engagement and capacity strengthening with media, the concept and how to counter militarised was discussed in broadcast and printed media.

In the **Democratic Republic of Congo**, the Section produced new research on communicating the concept of militarised masculinities and mobilising men for peace.


WILPF Nigeria collaborated with the Federal Ministry of Women Affairs to host the national dialogue on Nigeria's 3rd National Action Plan (NAP) on WPA. WILPF Nigeria also produced research highlighting the role that *Nollywood* films play in shaping gender perceptions.

In **Yemen**, the establishment of a Men Core Group (MCG) and its work has demonstrated the transformative potential of engaging male allies to support these goals, bridging divides and strengthening partnerships to build a peace process that reflects the needs and aspirations of all Yemenis.








